D. ACHIEVEMENTS AND SUCCESSES**1. Summarize your most innovative achievement or your greatest success story from the previous year.**

Ohio TechNet (OTN) launched OTN 2.0 which includes 16 additional schools supporting Ohio Manufacturers' Association's (OMA) launch of regional sector partnerships throughout Ohio. Quarterly in-person meetings were held with OMA's industry-led workforce leadership committee and members of the governor's cabinet to ensure continued progress. Two statewide manufacturing workforce summits took place: 11/1/17 and 11/1/18. Nearly 500 leaders from industry, workforce, and education attended each event. OTN project manager was the editor for SkillsCommons' MFG Editorial Board, guiding the SME review of 60+ MFG curricula. OTN assisted SkillsCommons with the launch of the OMA SkillsCommons portal.

In Y4, 2 TAA eligible individuals enrolled in TAACCCT funded programs. The average training duration for TAA eligible individuals was 16 weeks long, comparable to the training duration of non-TAA eligible participants. Both TAA eligible individuals were enrolled in programs that exceeded the period of performance, which ended on 3/31/18.

Report Certification / Additional Comments

Grantee Remarks:	Ohio TechNet's (OTN) sustainability strategies are working! As TAACCCT concluded, OTN invited Ohio colleges and universities to join OTN 2.0. To date, OTN has expanded from 11 to 27 schools: 23 community colleges and 4 universities. These partners value the sharing of best practices and challenges, and industry partners have a unified system to address talent needs. Capitalization on articulation progress and expanded relationships with K-12, career tech, and university systems will be prioritized for OTN 2.0. Employer engagement drives OTN success. OTN has engaged more than 500 employers, establishing a firm foundation for work-based learning, incumbent worker upskilling, and employment opportunities. Note: 21 non-incumbents completed in Y4, impacting employment outcomes; matches could not be made in HEI or UI wage employment data in instances where SSNs were not provided and where participants worked outside of Ohio; supplemental sources of data were used where applicable.
